Transportation Funding Guide for Santa Barbara County

Per the request of the South Coast Measure D Policy Development Committees, SBCAG Staff has prepared the attached tables identifying transportation revenues available from sources other than Measure D. The tables attempt to summarize the multitude of local, state and federal transportation funding sources typically available to our region and necessarily simplify a complex subject. We prepared the chart to give committee members the big picture perspective on funding transportation projects.

The funding programs are organized by transportation mode (eg. bicycle and pedestrian, highways, etc) and are forecasted for a thirty-year period that would cover the same timeline as Measure D Renewal. Information includes funding program name, annual funding using the base year amount for FY 2010/11, a 30-year projection of revenues; whether the program is discretionary (projects must compete for funding based on their merits) or formula based (funding is distributed to SBCAG or local agencies based on an allocation formula), who picks the projects, who can apply for the funds, and what the funds can be used for. The 30-year projection is staff's best estimate and assumes that current funding programs and amounts will continue.

Key Points:

1. Total revenue forecasted for the thirty-year period, 2010 to 2040, without Measure D Renewal is \$2.9 billion while the projected need is \$5 billion.
2. Without the \$1.05 billion projected from renewal of Measure D, our region's ability to leverage state and federal matching funds is reduced—the estimate of “lost” funding is between \$350 million and \$550 million.
3. Some funding sources are fungible and can be used for a variety of projects—others are less flexible and can be used only for specific projects or types of projects
4. Some funding programs are more reliable than others. In general, formula driven funding provides a more reliable funding stream than discretionary funding.
