

## STAFF REPORT

**SUBJECT:** 2015 Federal Transportation Improvement Program

**MEETING DATE:** December 18, 2014

**AGENDA ITEM:** 5A

**STAFF CONTACT:** Anne Jensen

**RECOMMENDATION:**

Adopt Amendment #1 to the 2015 Federal Transportation Improvement Program (FTIP) to update the SHOPP Roadway Preservation grouped project listing; to update the Highway Bridge Program grouped project listing; and to program a new, individually listed City of Goleta project that was recently awarded TIGER funds.

**DISCUSSION:**

The Federal Transportation Improvement Program (FTIP) is adopted by SBCAG and serves as a single document that the public and government agencies can review to understand where, when and how federal funding will be spent in Santa Barbara County. An accurate project description, including scope and funding allocated, must be listed in SBCAG's Federal Transportation Improvement Program before federal funds can be expended on the projects. After adoption, the FTIP must be periodically amended to facilitate expenditure. SBCAG's role is to amend the funding changes into the FTIP.

Amendment #1 makes the following changes to the 2015 FTIP:

**SHOPP3: Grouped Projects for Roadway Preservation – SHOPP Program**

A request by Caltrans to change one project in the grouped project listing; Highway 246 pavement rehabilitation near Buellton from 0.4 miles east of Santa Rosa Creek bridge to Route 101/246 separation. Funding increased by \$2,657,000, or 3.05%.

**CT 14: Grouped Projects for Highway Bridge Program**

The purpose of the program is to replace or rehabilitate public highway bridges over waterways, railroads, other highways, or other topographical barriers when the State and the Federal Highway Administration determine that a bridge is both significant for motorists and unsafe (because of structural deficiencies, physical deterioration, or functional obsolescence). Reimbursable scopes of work include replacement, rehabilitation, painting, scour mitigation, bridge approach barrier and railing replacement, low water crossing replacement, and preventative maintenance activities. About \$300 million of federal funds are made available to local agencies annually. Caltrans evaluates the candidate projects for eligibility requirements and includes the successful candidate projects in the Highway Bridge Program.

This amendment is requested by Caltrans. With this amendment, there would be 44 bridges in the SBCAG region HBP listing (versus the prior listing's 43 bridges). One (1) new bridge is being added and funding amounts are being changed for eight (8) bridges in the grouped project listing for a total decrease of \$2,360,388, or 7.36%. Additionally, some bridges in the grouped listing had funds moved to different phases or fiscal years, but these changes did not impact the total project amount. The 9 bridges with altered funding amounts are:

- City of Solvang: Bridge Preventative Maintenance Program: new bridge added to grouped listing to maintain various bridges in Solvang. Programs a total of \$345,875 in FYs 15/16 and 17/18.
- City of Goleta: Hollister Avenue over San Jose Creek: \$322,000 in engineering funds added to FY 15/16; \$250,000 in ROW funds added to FY 15/16; construction funds moved from FY 17/18 to Beyond and increased by \$6,063,200.
- City of Santa Barbara: Gutierrez Street over Mission Creek, De La Vina and Chapala Street: construction funds moved to future fiscal years and increased by \$167,250.
- City of Santa Barbara: Cota Street over Mission Creek, between Bath and De La Vina Streets: \$573,590 in construction funds added to FY 14/15.
- City of Santa Barbara: De La Guerra Street over Mission Creek, between Castillo and Bath Street: \$155,000 in construction funds added to future fiscal years.
- City of Santa Barbara: Mason Street over Mission Creek, between Chapala and State Street: \$400,000 in construction funds added to FY 14/15.
- City of Santa Barbara: West Cabrillo Boulevard over Mission Creek, between State Street and Helena Avenue: \$400,000 in right of way funds added to FY 14/15 and \$2,661,693 in construction funds added to FY 14/15.
- County of Santa Barbara: Jalama Road over Jalama Creek: increase of \$40,000 in FY 14/15 right of way funds and increase of \$1,350,000 in construction funds to FY 14/15.
- County of Santa Barbara: Jonata Park Road over Zaca Creek: FY 14/15 engineering funds increased by \$30,000.

### **GOLETA20: Old Town Goleta: Hollister Avenue Complete Streets Corridor Plan**

The amendment is requested by the city of Goleta and the Federal Highway Administration to include a project funded by the TIGER VI grant program. One new, individually listed project in Old Town Goleta, the Hollister Avenue Complete Streets Corridor Plan, is a planning project that will provide a comprehensive, implementation-oriented strategy for creating pedestrian enhancements along the 0.8 mile stretch of Hollister Avenue from Fairview Avenue to SR 217, including improvements to adjacent and connecting streets and interchanges as needed. Project programs a total of \$236,000 in recently awarded TIGER funds and a local match of \$47,200 in FY 15/16.

### **LOCAL HSIP: Grouped Projects for Safety Improvement – HSIP**

Amendment requested by Caltrans. One project on Highway Safety Improvement Program (HSIP) grouped project listing (City of Santa Barbara's De La Vina St. and W. Arrellaga Street traffic signal installation) has been awarded funds and removed from grouped project listing.

RESOLUTION NO. 14-32

WHEREAS, Title 23 Code of Federal Regulations, part 450, and Title 49 Code of Federal Regulations, part 613, require the preparation and updating of a Federal Transportation Improvement Program (FTIP) by the Metropolitan Planning Organization; and

WHEREAS, the Santa Barbara County Association of Governments (SBCAG) has been designated as the Metropolitan Planning Organization for Santa Barbara County; and

WHEREAS, SBCAG, through the conduct of a continuing, comprehensive, and coordinated transportation planning process with applicable federal requirements, has prepared a 2015 FTIP; and

WHEREAS, the 2015 FTIP has been prepared in cooperation with state and local government agencies including Caltrans, local transit operators; and the Air Pollution Control District; and

WHEREAS, the 2015 FTIP must be consistent with the Regional Transportation Plan adopted pursuant to Government Code Section 6508; and

WHEREAS, the 2015 FTIP projects have been developed from the 2008 Regional Transportation Plan, 2003 Congestion Management Plan, and 2014 State Transportation Improvement Program; and

WHEREAS, all projects proposed for federal funding or approval under Title 23 Code of Federal Regulations and the Federal Transit Act must be included in a transportation improvement program; and

WHEREAS, because Santa Barbara County attained the federal eight-hour ozone standard, it is no longer required to follow air quality conformity measures nor the applicable State Implementation Plan (SIP) as required by the federal Clean Air Act (42 U.S.C. Section 7401 et seq.); and

WHEREAS, the 2015 FTIP was made available for public review and members of the public were given a reasonable opportunity to review the 2015 FTIP before it was adopted by the SBCAG Board on September 18, 2014; and

WHEREAS, revisions to the FTIP requested by Caltrans in order to incorporate the FTIP into the statewide FTIP by the end of the federal fiscal year were adopted by the SBCAG Board on September 18, 2014 after public review;

WHEREAS, the 2015 FTIP is financially constrained and funds needed to complete the 2015 FTIP are reasonably expected to be available.

NOW, THEREFORE, BE IT RESOLVED that the SBCAG Board of Directors amends the 2015 FTIP to include the changes identified in the Staff Report Item 5B, December 18, 2014.

BE IT FURTHER RESOLVED that the SBCAG Board of Directors finds that development of the 2015 FTIP was made in accordance with public involvement procedures originally adopted by SBCAG on November 10, 1994 and updated on March 24, 2002 and December 20, 2007; and

BE IT FURTHER RESOLVED that the SBCAG Board of Directors finds that 2015 FTIP is consistent with metropolitan planning regulations from 23 Code of Federal Regulations Part 450; and

BE IT FURTHER RESOLVED that the SBCAG Board of Directors finds that the amended 2015 FTIP is consistent with the 2008 RTP.

BE IT FURTHER RESOLVED that the 2015 FTIP as amended is financially constrained and funds needed to complete the 2015 FTIP are reasonably expected to be available.

BE IT FURTHER RESOLVED that because Santa Barbara County attained the federal eight-hour ozone standard, the 2015 FTIP is not required to follow air quality conformity measures nor the applicable State Implementation Plan (SIP) as required by the federal Clean Air Act (42 U.S.C. Section 7401 et seq.); and

BE IT FURTHER RESOLVED that the inclusion of any federally-funded projects in the 2015 FTIP, including all amendments, constitutes the federal project selection procedures for Santa Barbara County, and any projects programmed in the FTIP may proceed to implementation without further project selection action by SBCAG.


