This letter serves as notification to Caltrans and the FHWA of Administrative Amendment #3 to SBCAG's 2023 FTIP. Pursuant to the authority delegated by Caltrans, minor modifications to the 2023 FTIP will normally be handled as administrative modifications and may be approved at the discretion of the SBCAG Executive Director. I have given my approval to this administrative modification that makes the following changes to the projects described below which is consistent with the requirements in 23 CFR 450:

Administrative Amendment No. 3 to the 2023 FTIP will program the following changes:

Grouped listings:

- Grouped Projects for Highway Bridge Program (MPO ID: CT14): The Spring bridge list update was released on March 22, 2023 (Attachment C). The grouped project listing is amended for a new funding total in the current FTIP years (FY 22/23 – 25/26) of \$50.1 million.
- Orouged Projects for Safety Improvement HSIP (MPO ID: LOCALHSIP): The list was released on March 15, 2023 (Attachment D). This listing includes Cycle 11 projects that are federalized as noted on the DLA website and shows state-funded projects for information only.
