This letter serves as notification to Caltrans, the Federal Highway Administration (FHWA), and Federal Transit Administration (FTA) of Formal Amendment No. 16 to SBCAG's 2025 FTIP. The SBCAG Board of Directors approved Formal Amendment No. 16 to the 2025 FTIP at their May 21st Board meeting. The amendment was presented to the public per guidelines established in SBCAG's adopted Public Participation Plan. The amendment makes the following changes described below, which are consistent with the Regional Transportation Plan and requirements in 23 CFR 450:

Formal Amendment No. 16 to the 2025 FTIP will program the following changes:

1. **SMOOTH Large Bus Purchase (MPO ID: SMOOTH12)** - This is a new project to purchase five large buses for the Santa Maria Organization of Transportation Helpers (SMOOTH). Total project cost is \$1,225,000.
2. **Community Partners in Caring Operating Assistance-5310 administered by Caltrans (MPO ID: CPC01)** - This is an existing project with additional Federal Transit Assistance (FTA) 5310 Elderly & Disabled funding being added. Total project cost is \$1,832,796.
3. **Highway 101/Highway 135 Interchange (MPO ID: SM55)** - This is an existing project with \$8.265 million in 2026 State Transportation Improvement Program (STIP) funds being added. Total Project Cost is \$55,719,000.
4. **Planning, programming, and monitoring (MPO ID: SBCAG11)** - This is an existing project with \$410,100 in 2026 State Transportation Improvement Program (STIP) funds being added. Total Project Cost is \$6,399,100.
5. **Cabrillo Underpass Replacement and Multi-Modal Improvements (MPO ID: SBCITY16)** - This is an existing project with \$1.5 million in Congressionally Directed Spending funds being added. Total Project Cost is \$58,196,000.

1. **Grouped projects for Highway Bridge Program (HBP) (MPO ID: CT14)**- This amendment will program the Spring bridge list update released on March 18, 2026. Total project cost is \$199,620,700. Shown as Attachment 5 to this staff report.
2. **Grouped projects for Roadway Preservation (MPO ID: SHOPP3)** - This amendment will update funding to two projects in the group listing. Total project cost is \$302,557,380. Shown as Attachment 3 to this staff report.

RESOLUTION NO. 26-08

WHEREAS, Title 23 Code of Federal Regulations, part 450, and Title 49 Code of Federal Regulations, part 613, require the preparation and updating of a Federal Transportation Improvement Program (FTIP) by the Metropolitan Planning Organization; and

WHEREAS, the Santa Barbara County Association of Governments (SBCAG) has been designated as the Metropolitan Planning Organization for Santa Barbara County; and

WHEREAS, SBCAG, through the conduct of a continuing, comprehensive, and coordinated transportation planning process with applicable federal requirements, has prepared a 2025 FTIP; and

WHEREAS, the 2025 FTIP has been prepared in cooperation with state and local government agencies including Caltrans, local transit operators; and the Air Pollution Control District; and

WHEREAS, the 2025 FTIP must be consistent with the Regional Transportation Plan (RTP) adopted pursuant to Government Code Section 65080; and

WHEREAS, the 2025 FTIP projects have been developed from the 2021 Regional Transportation Plan and 2024 State Transportation Improvement Program; and

WHEREAS, all projects proposed for federal funding or approval under Title 23 Code of Federal Regulations and the Federal Transit Act must be included in a transportation improvement program; and

WHEREAS, because Santa Barbara County is not classified as a nonattainment or maintenance area federal eight-hour ozone standard, it is no longer required to follow air quality conformity measures nor the applicable State Implementation Plan (SIP) as required by the federal Clean Air Act (42 U.S.C. Section 7401 *et seq.*) and the EPA's transportation conformity regulations (40 CFR Part 93, subpart A). (23 CFR § 450.326(a).); and

WHEREAS, the 2025 FTIP was made available for public review and members of the public were given a reasonable opportunity to review the 2025 FTIP before it was adopted by the SBCAG Board on September 19, 2024 (23 CFR § 450.326(b).); and

WHEREAS, revisions to the FTIP requested by Caltrans in order to incorporate the FTIP into the statewide FTIP by the end of the federal fiscal year were adopted by the SBCAG Board on September 19, 2024 after public review; and

WHEREAS, the 2025 FTIP is financially constrained and funds needed to complete the 2025 FTIP are reasonably expected to be available (23 CFR §§ 450.326(k), 450.104).

NOW, THEREFORE, BE IT RESOLVED that the SBCAG Board of Directors amends the 2025 FTIP to include the changes identified in the Staff Report for the 2025 Federal Transportation Improvement Program Formal Amendment No. 16, on May 21, 2026; and

BE IT FURTHER RESOLVED that the SBCAG Board of Directors finds that development of the 2025 FTIP was made in accordance with public involvement procedures originally adopted by SBCAG on November 10, 1994 and updated on March 24, 2002; December 20, 2007, October 20, 2011, August 20, 2015, and September 19, 2019 in accordance with Title 23, Code of Federal Regulations, section 450.316; and

BE IT FURTHER RESOLVED that the SBCAG Board of Directors finds that 2025 FTIP is consistent with metropolitan planning regulations from 23 Code of Federal Regulations Part 450; and

BE IT FURTHER RESOLVED that the SBCAG Board of Directors finds that the amended 2025 FTIP is consistent with the RTP adopted in 2021; and

BE IT FURTHER RESOLVED that the 2025 FTIP as amended is financially constrained and funds needed to complete the 2025 FTIP are reasonably expected to be available; and

BE IT FURTHER RESOLVED that because Santa Barbara County is not classified as a nonattainment or maintenance area for the federal eight-hour ozone standard, the 2025 FTIP is not required to follow air quality conformity measures nor the applicable State Implementation Plan (SIP) as required by the federal Clean Air Act (42 U.S.C. Section 7401 *et seq.*) and the

EPA's transportation conformity regulations (40 CFR Part 93, subpart A). (23 CFR § 450.326(a).);
and

BE IT FURTHER RESOLVED that the inclusion of any federally-funded projects in the 2025 FTIP, including all amendments, constitutes the federal project selection procedures for Santa Barbara County, and any projects programmed in the FTIP may proceed to implementation without further project selection action by SBCAG.



Commenter: Noe Puentes, Caltrans Office of Federal Programming & Data Management, 5/20/2026

- **MPO ID CPC01** – The toll credit amount is higher than its necessary based on the 50% required match of FTA 5310 funds. Based on the \$750,000 total, the required match is \$375,000. Because you have a local match of \$300,000; SBCAG's toll credit match is only \$75,000 for FY25/26.
- **SBCAG Response:** There is no local match on FY25/26 and it has been removed. The toll credit match is \$225,000 based on the FY25/26 total of \$450,000.

Commenter: Mark Mueller, City of Santa Maria, 5/21/2026

- **MPO ID SM55** The staff report and Attachment 1 state the revised project cost is \$57,719,000, but it is \$55,719,000.
- **SBCAG Response:** The total project cost in the description has been changed to \$55,719,000 to match the CTIPS total.
