Letter from Executive Director and Chairperson

We are proud to present the Measure A 2024 Annual Report, which showcases our progress in building safer communities together, as we promised voters when the measure passed in 2008.

Measure A revenues reached a record \$55 million in Fiscal Year 2023-24, demonstrating steady growth and reflecting the community's trust and support for this voter-approved transportation sales tax. These funds have been essential in improving road safety, enhancing bicycle and pedestrian infrastructure, and supporting public transit services such as the Clean Air Express, Coastal Express, Santa Barbara MTD, and commuter/passenger rail.

This year, we completed a major North County project—the Highway 166 and Black Road Traffic Signalization and Safety Project. Additionally, construction began on the Santa Barbara segment of the Highway 101: Carpinteria to Santa Barbara Project, which also opened new carpool lanes between Carpinteria and Montecito. These milestones highlight the impact of Measure A in creating safer and more reliable transportation for all. We remain focused on using Measure A funds effectively while leveraging them to secure additional resources for priority transportation projects and programs throughout Santa Barbara County.

Thank you for your continued partnership as we work together to build safer communities and a brighter future.

MEASURE A OVERVIEW



In November 2008, Santa Barbara County voters overwhelmingly approved Measure A, a local transportation half cent sales tax, with a resounding 79% majority vote.



Santa Barbara County is **1 of 25 Counties in California** with a transportation sales tax measure.







Accomplishment Highlights



Eight out of 15 regional infrastructure projects aimed to improve traffic congestion and mobility have already been completed.



Nine transit agencies received \$72 million for the purchase of new buses, providing reduced fares for elderly and disabled individuals, and covering operational expenses to reduce congestion.




104 bicycle, pedestrian, and safe routes to school projects in Santa Barbara County received a total of \$11.5 million in funding for safer street pathways, and improved infrastructure.



Smartride.org, which offers resources and incentives for commuters, helped 5,631 employees from 131 organizations save \$11 million in commuting costs while reducing 2.3 million car trips, benefiting both the environment and commuters.

New Traffic Signal Creates Safer Roads for the Community

The completion of the Highway 166/Black Road Traffic Signal Project has met a long-desired need to improve traffic flow and safety between Santa Maria and Guadalupe.

At the heart of this success is Measure A. Thanks to \$2.53 million in Measure A funding, this project benefits commuters, agricultural workers, freight operators in this key corridor.

The new upgrades at the intersection include modern traffic signals, turning lanes, enhanced lighting, high-visibility reflective markings, and improved drainage systems—features that prioritize safety and efficiency.

Local voices like Santa Maria Mayor Alice Patino emphasized the profound impact of Measure A initiatives. "This is more than infrastructure—it's an investment in our community's quality of life," said Mayor Patino. Supervisor Steve Lavagnino echoed these sentiments, noting how the improvements will have a lasting positive effect on public safety and regional connectivity.

The project showcases the collaboration between SBCAG, Caltrans, local municipalities—including the Cities of Guadalupe and Santa Maria, Santa Barbara County—and the engineering and construction teams Psomas, Rincon Consultants, MNS Engineers Inc., and Granite Construction.

The new traffic signal is a symbol of progress and a reminder of what's possible when communities and partners unite to create safer roads and a better future.

Highway 101 Construction Begins in the City of Santa Barbara

Construction began in September 2024 on Highway 101 in the City of Santa Barbara, marking the next phase of the Highway 101: Carpinteria to Santa Barbara. The Santa Barbara South project will add carpool lanes, soundwalls, ramp improvements, and will improve safety. The final segment, the Santa Barbara North project—between Hermosillo Road and Sycamore Creek is scheduled to begin in the Spring 2026 pending funding. The Santa Barbara North project includes carpool lanes, a redesigned Cabrillo Boulevard interchange, that removes left-hand off ramps and restores the Cabrillo Southbound on ramp and enhanced multi-use paths and sidewalks.

Easing Traffic Congestion and Honoring History

New carpool and High Occupancy Vehicle (HOV) lanes on Highway 101 between Santa Monica Road in Carpinteria and Sheffield Drive in Montecito opened in both directions. These peak-period HOV lanes ease traffic congestion as they complement previous HOV lanes opened in Carpinteria in 2022 and provide seven of the 11 miles of HOV lanes on the Highway 101 Carpinteria to Santa Barbara Project. The specific improvements in the Padaro and Summerland segments include new bridges at Toro and Arroyo Parida Creeks, interchange improvements at South Padaro/ Santa Claus Lane, a wider bridge at Evans Avenue, ramp improvements and sound walls. A special tribute to World War I Veterans is also included, honoring a 1928 memorial of oak trees and plaques planted by Boy Scouts and the American Legion. A new Blue Star Memorial Highway area features oak leaf-designed barriers, blue star plagues, and new signage sponsored by the Channel Islands District Garden Club. Additionally, more than 100 oak trees, grown from original acorns, will be planted along the freeway and at Loon Point Park in 2025.


NORTH COUNTY PROJECTS

The measure sets aside 43.3% of the funding to the North County and South Coast over a 30-year period for essential transportation projects. Part of the money goes to local cities and the county for street and transportation improvements. Another portion is dedicated to specific projects, selected by regional committees and approved by voters. These are those *named projects*.

Improve Highway 166 safety & traffic flow with passing lanes, turnouts, wider shoulders, new signals, and enforcement.



Highway 246 Passing Lanes

Improve Highway 246 safety with passing and turning lanes from Purisima to Domingos Roads.

Improve Lompoc access at Robinson Bridge with a flood-safe bridge, supporting vehicles, bicycles & pedestrians

Safety Enhancements for Nearly 7,000 Students in Orcutt

More than \$664,000 in Measure A competitive grant funding is bringing critical bicycle, pedestrian, and safety improvements to North County. One key project, the Orcutt School Crossings Safety Improvements, received \$184,800 in 2024—covering 82% of its costs. The upgrades include accessible ADA-compliant push buttons and Leading Pedestrian Intervals (LPI), which improve crosswalk safety by increasing visibility at four busy intersections near school routes. These enhancements will directly benefit nearly 7,000 students across 13 local schools, ensuring safer, more accessible commutes. The project is expected to be completed by December 2025.

Renewed Focus on Highway 166 Safety

In 2012, the SBCAG Board approved four projects to be funded out of the Measure A Investment Plan allocation of \$3 million for Highway 166 Safety and Operational improvements, including a limited enforcement grant program with the California Highway Patrol (CHP). The Measure A funded CHP safety enhancements were implemented between 2015 to 2019. In 2024, CHP Santa Maria Area Commander, Joseph Rodriguez, highlighted a concerning rise in collisions and injuries on Highway 166 since 2020 compared to the period of 2015-2019, when Measure A-funded enhanced enforcement. To address the rise in collisions, the Board approved a new three-year enforcement program with the CHP using \$202,679 from Measure A cost savings. The plan includes 1,200 additional officer hours and 140 Sergeant hours, focused on enhancing safety on both Highway 166 East and West.

Lower Fares, Higher Impact for Seniors and **People with Disabilities**

Specialized transit services are a lifeline for elderly and disabled community members. Thanks to Measure A, these essential programs in North County get a boost in funding to help reduce fares for those who need it most. Measure A has invested over \$2.4 million in North County to support the operating expenses of vital transit providers like City of Lompoc Transit, Guadalupe Transit, Santa Maria Area Transit, the Santa Maria Organization of Transportation Helpers, and Santa Ynez Valley Transit. By lowering transportation costs, Measure A ensures that seniors, people with disabilities, and others facing transportation challenges can stay connected to their communities, healthcare, and daily necessities.

Cutting-Edge Technology for Road Maintenance

The City of Santa Maria entered a new era of road maintenance in 2024 with the acquisition of a state-ofthe-art asphalt paver, funded entirely by Measure A. The equipment, a Vögele Super 700i Asphalt Paver, requires fewer crew members and significantly improves paving efficiency compared to previous methods done by manual labor. This advancement enables maintenance crews to pave full lanes and roadways, boosting productivity. The community is already experiencing the benefits of smoother, more durable roads enhancing daily commutes.



PARTNERING FOR SUCCESS: SOUTH COAST

Redesigning Cathedral Oaks Road for Active Transportation

More than \$8.3 million in Measure A competitive grant funding has been spent to bring essential bicycle, pedestrian, and safety improvements to the South Coast. Among these projects is the Santa Barbara County Cathedral Oaks Complete Streets Redesign effort which received nearly half a million dollars in 2022. This initiative focuses on enhancing bicycling and walking along Cathedral Oaks Road. To achieve this, the County is collaborating with consultants to study and develop alternative designs for the stretch of Cathedral Oaks from Cambridge Drive to the Highway 154 overpass. Proposed improvements include new bike facilities and safer pedestrian crossings. The project began in 2024 and is expected to be completed by 2025.

New Multiuse Path Opens at Santa Barbara Junior High

A project to transform the area near the main entrance of a local junior high school was completed in August 2024. The Santa Barbara Junior High School Multiuse Path Project, funded by Measure A through the Safe Routes to School program, enhances safety and accessibility for students, cyclists, and pedestrians. Key improvements include a widened twelve-foot multiuse path at the school's entrance, a bypass for cyclists to avoid drop-off zones, and new street lighting to improve visibility. The design also preserved mature street trees, maintaining the area's natural charm and the neighborhood's character.

Measure A Amendment Reflects Evolving Transportation Needs

The SBCAG Board approved an amendment to the Measure A Ordinance and Investment Plan, renaming the Goleta Overpass Improvement project to City of Goleta Project Connect and updating its focus. The original project called for a new overpass in west Goleta over Highway 101 and the Union Pacific Railroad to improve traffic flow and safety, has been deferred due to funding and feasibility issues. It is no longer a named Measure A project, but Goleta remains committed to a bike and pedestrian overcrossing included in SBCAG's Regional Transportation Plan.

City of Goleta's Project Connect, the City's largest capital improvement project, prioritizes pedestrian safety, road improvements, and stormwater flow capacity in San Jose Creek under Hollister Bridge. Construction began in Spring 2024 and will finish in 2026. The amendment highlights Goleta's dedication to enhancing connectivity and evolving transportation priorities.

15th Annual CycleMAYnia Celebrates Cycling in Santa Barbara County

The 15th annual CycleMAYnia 2024 concluded with the announcement of Harrison Baugh, a senior at Santa Ynez High School, as the winner of a brand-new e-bike. More than 950 Santa Barbara County residents took part in 57 National Bike Month activities, engaging kids, families, adults, and commuters throughout May. In May alone, bike trips prevented 5 tons of CO2 emissions, burned over 500,000 calories, and saved participants a combined \$7,000 compared to driving. CycleMAYnia is a collaborative effort between public entities and private organizations, leveraging community resources and South Coast transportation sales tax Measure A Bicycle and Pedestrian funds to foster and support community-driven activities.



Measure A Citizens Oversight Committee

Since 2009, the Measure A Citizens Oversight Committee has upheld public accountability and transparency to ensure provisions of Santa Barbara County's voter approved Measure A Investment Plan and Ordinance are properly carried out. Working alongside SBCAG, these dedicated civic leaders receive updates on Measure A programs and projects and review annual audits for compliance before presenting an annual letter of confirmation to the SBCAG Board of Directors, the Santa Barbara County Local Transportation Authority. Their invaluable service as an all-volunteer committee helps to ensure that Measure A funding at work in the region is on track to reaching its ambitious goals laid out by voters years ago.

The committee is comprised of eleven appointed members: four representing the North County, four representing the South Coast, and three at-large members. Service on the committee is voluntary and the appointees have proven to be invaluable partners within their advisory role and as community ambassadors.
