CURRENT PROJECT DESCRIPTION

This project proposes to improve the operations at the interchange of Highway 101 and Betteravia Road by constructing in the south east quadrant of the interchange in the City of Santa Maria. The proposed improvements shall consist of constructing a northbound loop on ramp to accommodate eastbound Betteravia Road traffic and a revised northbound offramp with the objective to improve traffic circulation for vehicles, including current and future freight operations, entering and exiting Highway 101 at Betteravia Road and for local through traffic on Betteravia Road. Improvements will be made to the Betteraria Road Overcrossing and on either side east and west to accommodate both pedestrians and bicyclists.
